## Competition Brackets

- This presentation provides various examples of tournament brackets (for Trophy, Team, Hot Saw Showdowns and others), which are based on the number of participating athletes in the specific competition.
- It is not intended to be complete. If other options are required, please discuss these with the Global Sports Directors and HQ.
- Every tournament bracket must be preceded by a time trial. The time trial determines the positioning in the actual bracket.
- If the number of athletes falls between two brackets, a decision must be made as to which bracket to use. The time trial determines which athletes are eliminated from the competition and which go through to the first round of the knockout system.

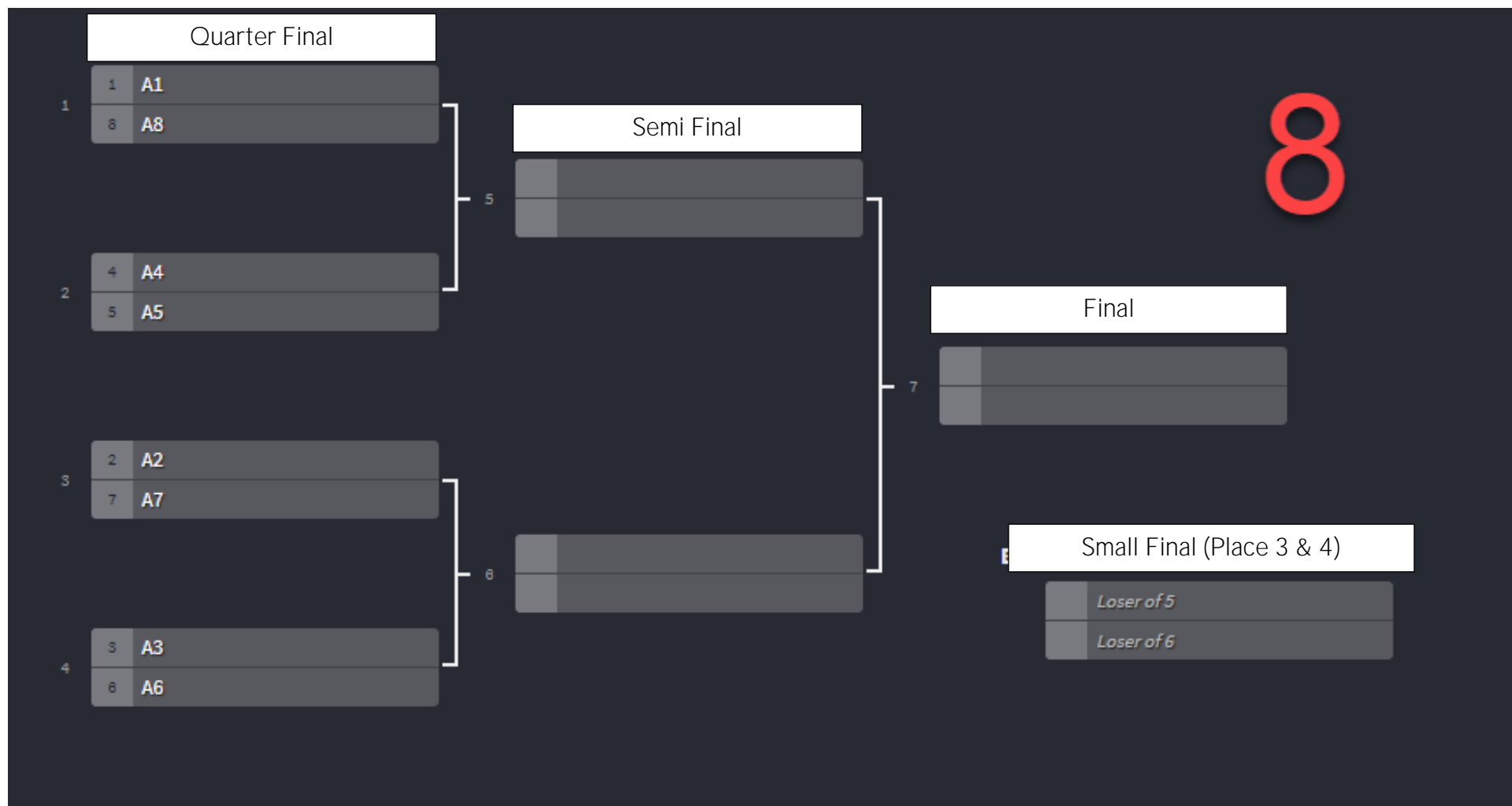

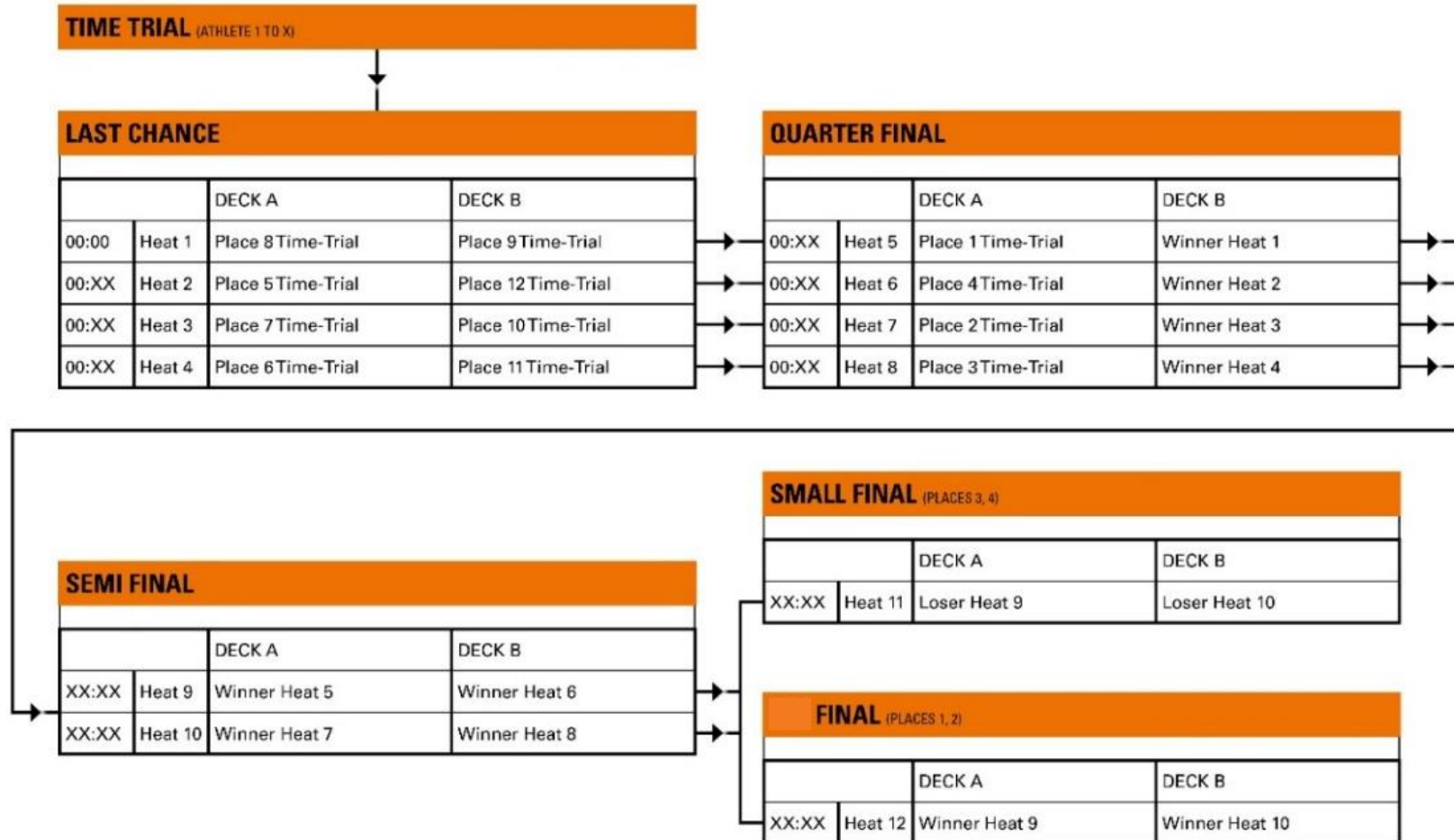
